- BBG and its subsidiaries were showcased on the global stage in 2014 as a co-organizer of the World Stem Cell Summit
- BBG subsidiary South Texas Blood & Tissue Center continued to improve the donor experience with efficiencies that help put blood products on the shelf for patients
- BBG subsidiary QualTex Laboratories tested a record number of regulated biologic product samples worldwide
- BBG subsidiary GenCure sent a record number of umbilical cord blood units around the world for transplant into seriously ill patients

BBG CEO Linda Myers says in the report's opening message that BioBridge Global has refined an infrastructure that holistically supports its mission and the regenerative medicine industry.

"Every facet of BioBridge Global enables research and development as we continue our longtime service to the community, bringing hope to the ill and injured in Texas and around the world," she says.
